COMPLAINT FOR SOVEREIGNTY

MAY I PLEASE THE COURT on this the 18th day of February 2009 in
presenting this Complaint for Sovereignty from the United States of America on behalf of
myself, and/or as well as the Vampyre Nation which I represent.

1a) THE PLAINTIFFS; Jonathon Sharkey, Ph.D., L.D.D.D. herein known as –
Jonathon, who is presently an inmate at Olmsted County Adult Detention Center, in
the City of Rochester, in the County of Olmsted, in the State of Minnesota, Zip Code
55904. I am filing this Complaint Pro Se. However upon the VN's Attorney General's
return from Sicily, she will take over the prosecution of this litigation;

1b) The Vampyre Nation herein known as – VN, which consist of several territories
here in America, as well as in other nations in the world (Russia, Romania, Poland,
Germany, South America, Australia...). The VN's primary location is in Tracy City,
Tennessee. The VN's mailing address is; P.O. Box 361, in the City of Tracy City, in
the County of Grundy, in the State of Tennessee, Zip Code 37387;

2) **THE DEFENDANT;** The United States of America, herein in known as – U.S. who’s headquartered in the City of Washington, District of Columbia, Zip Code 20530. The U.S. is represented by the U.S. Attorney General’s Office, located at – The U.S. Department of Justice, 950 Pennsylvania Avenue, NW, in the City of Washington, in the District of Columbia, Zip Code 20530;

3) **FEDERAL STATUES SUPPORTING THIS ACTION;**

A) The Declaration of Independence (see attachment #1)

B) The U.S. is a Defendant in this action.

4) **COUNTS AGAINTST THE DEFENDANT;** by way of these allegations,

Jonathon now states the following allegations against the U.S., as well as why this Court should hear this matter, and render a decision in favor of the Plaintiffs;

BACKGROUND INFORMATION

A) Back on 4 Jul 1776 the Founding Fathers of America, in a unanimous Declaration of Independence against the British Government stated; “When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature’s God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation”;

B) Jonathon is a Sanguinarian Vampyre, as well as a Hecate Witch. On 13 Sept 05 he filed his paperwork with the Federal Election Commission (FEC) to run for President of the U.S. in 2008 under the VWP (Vampyres, Witches and Pagans) Party. On 13 Jan 06 in Princeton, MN, Jonathon announced his candidacy for

Governor of Minnesota (Google – Jonathon Sharkey). Jonathon filed a notice in 2008 with the FEC that he denounced his U.S. Citizenship in retaliation for the negligence and Civil/Human Rights violations committed upon not only him, but his people as well by the U.S. Jonathon's wife Amaya is a Psi/Sang Vampyre;

- C) On 10 Mar 08, Jonathon wrote a letter and faxed it directly to President Bush at The White House (Jonathon has had President Bush's direct fax number since getting it from President Bush's brother Jeb Bush in 2001) stating that Jonathon and those he represented at the VN wanted their Independence and Sovereignty from the U.S. (see attachment #2). The letter also stated that the VN had it's own Constitution that would take affect on 13 Apr 08;
- D) On 13 Apr 08 the VN's Constitution took affect (read the VN's 41 page Constitution at: www.thevampyrenationsofficialgazette.blogspot.com The site has been tampered with, but the Constitution is still there)
- E) On 18 Aug 08 as a result of President Bush's unprofessional actions of failing to respond to Jonathon's letter of 10 Mar 08, Jonathon along with his wife – Queen Amaya sent Bush another letter (see attachment #3). This letter included the VN's Declaration of Independence (see attachment #4) (which is very similar to the one written by the U.S. Founding Fathers), as letter a request for the U.S. to turn over certain terrorists and criminals that have either attacked citizens of the VN, or violated the VN's Constitution. As of this date, the U.S. has failed to respond to the VN's Declaration;
- F) The VN has its own form of Government (see the VN's Constitution) which is a monarchy, as well as having appointed/elected leaders. The VN's has; a King

(Jonathon), a Queen (Amaya – Jonathon’s wife who unfortunately has committed several crimes against the VN (High Treason, Treason, Murder of a member of the Royal Family..., as well as violated several of the Vampyre laws and is scheduled to be tried shortly for her crimes. Upon being found guilty, she will be execute in accordance to Vampyre Law), a (female) Seer, a (female) Prime Minister, a (female) Ambassador, a (female) Attorney General, a (female) United Nations Ambassador (for when the VN gains acceptance into the UN), a (male) Minister of the Military along with other ministers and officials;

- G) The VN has a military. The elite military unit of the VN’s Military are known as – Death Dealers. Additionally there is another elite unit of the VN’s Military known as – the VN’s Ranger. Beside the VN’s elite units, there is a regular Army. The VN’s Military has a weapons deal with Russia (Queen Amaya is Russian);
- H) Just like South Ossetia and other European nations, the VN is a Russian loyalist, not a U.S. loyalist;
- I) The citizens of the VN are not only Vampyres, but are; Witches, Pagans (the oldest religion in the history of the world) Wiccans, Satanists, Luciferians, Lycans and other non-Christian based beliefs and kindred people;
- J) The VN’s Declaration of Independence was an act of secession from the U.S., just like the Confederate State did almost 150 years ago;
- K) The VN has many avenues to generate self sustaining revenue, if only we didn’t have to worry about intrusion from the U.S.;
- L) Neither Jonathon nor the VN speaks for or represents every; Vampyre, Witch, Pagan, Wiccan, Satanist (especially those who belong to COS), Luciferian, Lycan

and other Kins of the Communities. Jonathon and the VN speaks for those who wish to be and are affiliated with the VN;

M) The VN is prepared to proceed from the assumption that to be respected by the U.S., we have to use brute military force to gain our sovereignty and Independence;

N) Jonathon has approached the United Nations in his attempt to gain acceptance of the VN in the International World (see attachment #5);

PRECEDENCE FOR THIS ACTION

There are several precedent cases for this cause of action. They are and not limited to;

- A) The U.S. as previously stated on 4 Jul 1776, America's Founding Fathers Declared in unison their desire to be a free nation, and separated from British rule;
- B) In early 2008, Western Countries recognized Kosovo as a Sovereign Nation, after they declared their Independence (see Time Magazine 25 Aug 08);
- C) Abkhazia declared their Independence from Georgia in 1999, and with the help of Russia went to war with Georgia to achieve their Independence;
- D) There is several other incidences of Countries Declaring their Independence, and at times going to War to achieve their Independence;
- E) The American Indians have their own Reservations and land supplied to them by the U.S., as well as their own laws and government (even though the Indians sided with the British Government against Americans Founding Fathers during the American Revolutionary War);

COUNT ONE – CIVIL/HUMAN RIGHTS VIOLATIONS

These Civil/Human Rights Violations caused by the U.S. are, and not limited to the following;

A) Since 1692, when Massachusetts was a colony, those who practice “Witchcraft” (a ritual of the Pagan and Wiccan belief) have been repeatedly attacked, prosecuted, persecuted, lived in fear, suffered Civil/Human Rights Violations at the hands of the U.S. Government and/or its agents;

B) (Here are a few example that I have witness and/or suffered) On or about 10 Jun 08 Olmsted County Assist Prosecutor Jeffrey D. Hill filed charges against him for as he states “harassing my ex-girlfriend from 15 Aug 07 to 24 Aug 07.” However, it did not matter to him or the Olmsted County Judicial System that the alleged victim was an admitted Vampyre Hunter (see attachment #6). Jonathon is one of the most known and infamous Vampyres in all the world, and has been the victim of several Vampyre Hunter attacks;

C) Even though Jonathon filed a Motion for a Continuance with the presiding court in Olmsted County, MN to have his initial appearance postpone as a result of having his left knee snapped by a Vampyre Hunter and was recuperating from surgery, the Court denied his motion. On 27 Sept 08, Olmsted County, MN faxed an Arrest Warrant to Grundy County, TN to take Jonathon into custody at his home on VN property. Per Olmsted County’s request, Grundy County knowing Jonathon was recuperating from knee surgery sent a SWAT Team to take Jonathon into custody. The SWAT Team slammed Jonathon’s wife Amaya to the ground, and placed their M-16’s in her face (not a smart thing for an American law enforcement group to do a RUSSIAN woman);

D) From 10 Jun 08 to present, Olmsted County, MN and Grundy County, TN have repeatedly violated Jonathon's Civil Rights (see attachments #7). The action of said countries has caused the U.S Department of Justice to start a Federal Investigation (see attachment #8). The only reason why DOJ is investigating this matter is because Jonathon's Tennessee attorney is friends with one of the U.S. Attorney's in Chattanooga. If not for that, the U.S. wouldn't lift a finger to help Jonathon;

E) On 13 Jan 06 after Jonathon announced his candidacy for Governor of MN, his Pagan wife at the time Julie Carpenter was fired from her job as a School Bus driver because the School Board in Princeton, MN stated she was a "WITCH" and that Jonathon was an admitted Vampyre (go to www.wcco.com and search Julie Carpenter). Julie never stated she was a "WITCH," only that she was Pagan. Yet, she was still fired. The U.S. failed to protect her rights, as well as Jonathon's in this matter. Not to mention, the U.S. never prosecuted those responsible for violating Julie's Civil Rights;

F) In 2005, Marion County, IN Superior Judge Cale Bradford while divorcing a Wiccan couple, ordered the couple to not teach their children their Wiccan beliefs/religion. The U.S. DOJ did not prosecute nor investigate Bradford for his unconstitutional actions. Fortunately, Ken Falk of the ICLU (IN Civil Liberties Union) in Indianapolis appeal Bradford's unlawful decision, and the IN Court of Appeals overturned Bradford's ruling;

G) How was Judge Bradford punished for his unlawful act? In 2006 he was made an IN Court of Appeals Judge. (Only in America!);

H) School through the U.S. have told countless of students who were either; Vampyre, Witches, Wiccan, Pagan, Satanist, Luciferian... that they could not wear symbols of their faith - like a Pentagram. The ACLU has had to argue in Court that these students' rights were repeatedly violated, and that the U.S. and their agents (city schools) repeatedly violated the 1st Amendment Rights of; Vampyres, Witches, Pagans...;

I) There are hundreds, if not thousands of unlawful and Civil/Human Rights violations committed by the U.S. upon civilians of the VN. More can and will be supplied at hearing, or upon request of this Court or the U.S. (go to: www.witchvox.com and read about how Pagans, Wiccans, Witches have suffered repeated violations of their rights);

J) When the ACLU or legal representatives have to file a Complaint in Court against the U.S. or its agents, it is because an American Law has been violated. Hence the U.S. and/or its Agents have committed a criminal act;

COUNT TWO – SOVEREIGNTY THROUGH WAR

The Plaintiffs repeat their allegations in Count One as well as the allegation made in this Count;

A) Shortly after America's Founding Fathers unanimously Declared their Independence, the American Revolutionary War ensued;

B) American's Founding Fathers sought help from their allies (like the French) to defeat the British Army, and secure the Independence that the U.S. enjoys today;

C) In the VN's Declaration of Independence to President Bush (see attachment # 4), we stated that we have the right to make alliances, as well as have the right to declare war;

D) Following in the Founding Fathers footsteps, the VN has the right to seek help and support from our allies (Russia) and countries that hate the U.S. to engage in a War for our Independence, if the U.S. refuses to acknowledge our Declaration of Independence and grant us Sovereignty;

E) The U.S. cannot categorize such a military action as an act of terrorism for history has shown many counties to include the U.S. had to win their Independence through military strength;

F) Russia has a history of going after territories it wants. Hence, the VN has the International precedence by Russia (and other countries) to acquire land by purchase or military force;

G) Like Russia, Jonathon and the VN fully believe that amassing military strength or using violence helps restore self-respect and honor. Especially since the citizens of the VN feel a sense of victim-hood because of suffering repeated Civil/Humans Violations by the U.S and its agents;

COUNT THREE – NEGLIGENCE

The Plaintiffs repeat the allegations in Counts One and Two, as well as made in this Count;

A) In all of the above allegations of Civil/Human Rights Violations, the U.S. and/or it's agents (as in States) were negligent in not protecting the rights of American people

who are; Vampyres, Witches, Pagans, Wiccans, Satanists, Luciferians, Lycans and other Kins of the Vampyre Nation;

B) The U.S. Government cares more about the rights and liberties of those of Christian based religions, than they do of non-Christian based religions;

COUNT FOUR - THE NEW PRESIDENT/ADMINISTRATION

The Plaintiffs repeat the allegations in Counts One, Two, and Three as well as made in this Count;

- A) On 20 Jan 09 Barack Obama was sworn in as the 44th President of the U.S.;
- B) Obama is of the Muslim faith;
- C) Muslims are sworn enemies of; Vampyres, Satanists, Witches and other Kins;
- D) Muslims and Vampyres have been at war with each other for centuries;
- E) With the fact Obama being of the Muslim faith, neither Jonathon nor the VN expects any better protection for our people's rights;

AS A RESULT OF THE ACTIONS OF THE U.S., JONATHON AND THE VN DEMANDS THE FOLLOWING THROUGH THIS COMPLAINT;

- 1) **That the U.S. accepts our Declaration of Independence and abides by the terms mentioned in said Declaration (see attachment #4);**
- 2) **That the U.S. sign an agreement not to intrude of the affairs and government deals of the VN;**
- 3) **That the U.S. sponsors the VN for acceptance into the United Nations and NATO;**
- 4) **That the U.S. pass into Law the VWP Protection Act written by Jonathon (a copy is available upon request);**

- 5) That the U.S. gives to the VN large accounts of land in the U.S. (as they did for the Indians) as in the State of Minnesota;
- 6) That the U.S. gives to the VN a large sum of money (several \$100 millions) to aid the VN (like the U.S. has done to other countries) in it's development;
- 7) Any and all relief the Court deems to be just and fair.
